- 1. Pursuant to the DepEd Memorandum # 144 s. 2019, this Division announces the conduct of the 2020 Metrobank-MTAP-DepEd Math Challenge, Division Team Finals on February 6, 2020 (Elementary Level) and February 7, 2020 (Secondary Level) at Cogon National High School, Cogon, El Salvador City, Misamis Oriental. The opening program shall start at exactly 8:00 o'clock in the morning and competition will follow for every category of competition, respectively.
- 2. The participants are the Top 8 scorers for Elementary and Top 6 scorers for Secondary Schools during Elimination Round held last January 16 & 17, 2020. Only Grades 6 and 10 qualifiers in both individual and team categories can participate in the regional and national levels. Further, participants are expected to report to the venue at exactly 7:00 A.M.
- 3. Working committee/officials are expected to perform their respective roles in the conduct of the Division Team Finals. (See Enclosure No. 1 List of Working Committee/Officials). Arrangement for substitute officials must be facilitated earlier to ensure that classes of the participating teachers/coaches/officials will not be disrupted.
- 4. Expenses incurred for meals/snacks of working officials and materials shall be charged against local funds, while transportation, meals/snacks of the participants and coaches shall be charged against local funds/PTA subject to usual accounting and auditing procedures/policies, rules and regulations.
- 5. Immediate dissemination of this memorandum to all concerned is earnestly desired.
