Procedure in Applying for CHED Scholarship Programs (CSP) and CHED-Tulong Dunong Program (CHED-TDP) for Academic Year 2020-2021

- 1. Prepare the complete documentary requirements.
 - Citizenship: Certified true copy of Birth Certificate
 - · Academic:

For Incoming Freshmen:

Senior High School Graduate

Certified True Copy of Grades with General Weighted Average (GWA) in Grade 12 (1st and 2nd Semesters)

Candidate for Graduation in Senior High School

- Certified True Copy of Grades with GWA in Grade 11 (1st and 2nd Semesters)
- Certified True Copy of Grades with GWA in Grade 12 (1st Semester only)

Alternative Learning System (ALS) Passer

- Duly Certified Copy of Alternative Learning System (ALS) Accreditation and Equivalency Test Passer Certificate
- > Photocopy of Diploma from DepEd

Philippine Educational Placement Test (PEPT) Passer

- Duly Certified Copy of Philippine Educational Placement Test (PEPT) Certificate of Advancing to the Next Level
- > Photocopy of Diploma from DepEd

For Applicants with Earned Units in College

- Duly Certified True Copy of Grades for the latest semester/term attended with GWA
- Financial: Any one (1) of the following documents:
 - Latest Income Tax Return (ITR) of parents or guardian;
 - Certificate of Tax Exemption from the Bureau of Internal Revenue (BIR);
 - ➤ Certificate of Indigence either from their Barangay or Department of Social Welfare and Development (DSWD);
 - Case Study report from DSWD; and
 - Latest copy of contract or proof of income may be considered for children of Overseas Filipino Workers (OFW) and seafarers.

Other Requirements:

Certificates and/or identification cards issued by the appropriate offices or agencies for student-applicants belonging to the special group of persons such as the Underprivileged and homeless Citizens, PWDs, Solo Parents and their Dependents, Senior Citizens and Indigenous Peoples



- 2. Scan or take a picture of the complete documentary requirements clearly.
- 3. Open the link https://forms.gle/XSNWTyGSgoNuCiQn7.
- 4. Log in to the system using your Gmail Account (i.e. juandelacruz@gmail.com). If no account, please create a G-mail Account.
- 5. Accomplish completely the CHED Student Financial Assistance Program (StuFAPs) online application. Use CAPITAL LETTERS in filling the form.
- 6. Wait for the notification from CHED. Qualified applicants will be given detailed instruction through E-mail, SMS or letter.

- 1. The application period is from March 1 to May 31, 2020.
- 2. The student-applicant should enroll in any of the Priority Courses (CMO No. 5, S. of 2019) identified by CHED for CHED Scholarship Programs (CSP).

CHED MEMORANDUM ORDER (CMO)

No. 05 Series of 2019

SUBJECT: PRIORITY COURSES FOR CHED SCHOLARSHIP PROGRAMS (CSPs) FOR ACADEMIC YEAR 2019-2020

Pursuant to CHED en Banc (CEB) Resolution No. <u>264-2019</u> dated 30 April 2019 in relation to Section 8 (i) and (n) of Republic Act No. 7722, otherwise known as the "Higher Education Act of 1994," and the General Appropriations Act (GAA) for FY 2019 under Special Provision(s) stating that "The CHED shall likewise prioritize courses aligned with global innovation platforms of Science, Technology, Engineering, Agri-fisheries and Mathematics (STEAM) as well as the priorities of the government in key growth areas, such as semiconductor and electronics, business process outsourcing, tourism, general infrastructure and other priority manufacturing industries in the grant of scholarships," this CMO containing the priority courses for CHED Scholarship Programs (CSPs) is hereby issued for Academic Year (AY) 2019-2020.

Rationale and Policy Statements

The priority courses are hereby identified to direct/steer higher education students who are recipients of financial assistance under the CSPs to enroll in public or private higher education institutions (HEIs) offering recognized/authorized undergraduate priority courses. For purposes of this CMO, priority courses as hereinafter identified refer to the recognized or authorized undergraduate degree programs offered by public or private HEIs.

The determination of the priority courses was a result of the studies and deliberations conducted by the Technical Working Group (TWG) composed of representatives from CHED and UniFAST Secretariat, Department of Trade and Industry (DTI), National Economic and Development Authority (NEDA), Technical Education and Skills Development Authority (TESDA), Department of Labor and Employment (DOLE), Department of Science and Technology (DOST), Philippine Association of State Universities and Colleges (PASUC), and the Coordinating Council for Private Educational Associations (COCOPEA), in line with the National Development Plan on manpower demands based on the JobsFit 2022 Labor Market Information (LMI) Report of DOLE.

Students who are enrolled in any of the priority courses listed in this CMO may avail of the benefits under the CSPs, depending on the type of scholarships they were able to qualify, which shall be in the form of tuition and stipend. The financial assistance under the CSPs shall be harmonized with the monetary benefits under the Unified Student Financial Assistance System for Tertiary Education-Tertiary Education Subsidy (UniFAST-TES), as well as with the free tuition and other school fees privilege provided in Republic Act No. 10931, the Universal Access to Quality Tertiary Education Act (UAQTEA).

The financial assistance under the CSPs is merit-based which can be availed of by the students enrolled in recognized priority programs of Private Higher Education Institutions (PHEIs), or in priority programs offered by State Universities and Colleges (SUCs) with Certificates of Program Compliance (COPCs) and CHED-accredited Local Universities and Colleges (LUCs).

For the effective implementation of this CMO, the CHED Regional Offices (CHEDROs) shall ensure that the Priority Courses herein listed are properly distributed according to the regional needs and availability of slots.

IV. Career Guidance

The CHED, in collaboration with the Department of Education (DepEd) and DOLE, shall intensify the promotion of identified priority courses through Career Guidance Advocacy Program (CGAP). For this purpose, all graduating beneficiaries of CHED StuFAPs are encouraged to register in the PhilJobNet (www.philjobnet.gov.ph), a government online job portal, in order to avail of the job search assistance and other employment facilitation services. The PhilJobNet also provides career information advice and other featured articles that the students may use as tools in making career choices.

V. Repealing Clause

All other existing Orders and Memoranda issued by the Commission, which are contrary to or inconsistent with any of the provisions of this CMO are hereby deemed repealed or modified

Separability Clause VI.

If any part or provision of this CMO is declared invalid the remaining clauses/provisions not affected thereby shall remain valid and enforceable.



This CMO shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation and shall remain in force and effect until revoked or amended.

This CMO shall apply to pending applications submitted to the CHEDROs concerned prior to the effectivity thereof.
