- 1. DepEd Order 39, s. 2016 (Adoption of the Basic Education Research Agenda) highlights the significant contribution of research to fully establish policies and implement goals directed towards the learners; thus, effectively instigating the Department of Education's mandate consistent with its vision. Accordingly, priority themes surfaced as research areas that are most necessary and practical in light of the Department's objectives. Major reforms and implementations in the educational setting are anchored on reliable researches and validated data. Thus, research activities are stipulated in the Division Research Agenda.
- 2. To ensure a quality and time-bounded research outputs, this Office informs the field of these research guidelines relative to the Special Education Fund (SEF) grant of 2,000 php per employee:
 - a. A 6,000-word research output (excluding annexes) shall be submitted following the research phases;
 - b. Maximum of 3 proponents per (1) research is allowed;

- Researches may be anchored, but not limited to the themes provided in the Division Research Agenda;
- d. Submitted researches for SEF should have followed the research ethics including the anti-plagiarism consent form;
- e. Research should be used and submitted exclusively for the SEF and should not be published or submitted in any other research fora
- f. Research-based innovations, projects and programs are also accepted
- 3. Further, the School-Based Research Committee shall do initial screening and review on researches before submission to the Division Level.
- 4. For a systemic submission mechanism, the following timelines should be observed:

| Timeline | Activity |

| January-February | Research Planning |
| March-May | Concept Paper Presentation & Review (School-Based Research Committee or Section Review-for DO Level) |
| June | Proposal Presentation |
| June-August | Data Gathering & Completion of Research Outputs |
| September | Submission of Research Outputs to School Committee/ Section Heads |
| October | Submission of Finalized Output to Division Level |
