WORK ARRANGEMENT WITH REFERENCE TO RESOLUTION NO. 118-A, S. 2021 ISSUED BY THE INTER-AGENCY TASK FORCE (IATF) FOR THE MANAGEMENT OF EMERGING INFECTIOUS DISEASES

- With reference to Resolution No. 118-A, s. 2021 issued by the Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases, the current risk-level classification are as follows:
 - a. Misamis Oriental- Modified General Community Quarantine (MGCQ) until June 30, 2021
 - Cagayan de Oro City Modified Enhanced Community Quarantine (MECQ) until June 15, 2021
- 2. As per records, this Division have employees who are residing in Cagayan de Oro City. In consideration of the restrictions in the transportation, all employees who are residing in Cagayan de Oro City are hereby advised to work from home until June 15, 2021. Item 16.a.iii of DepEd Order 11, s. 2020 is reiterated for this purpose:
 - Head of offices and schools shall ensure that personnel are given tasks to be performed to the full extent possible in terms of persondays per workweek;
 - Personnel under WFH shall make themselves available and accessible during working hours, and must be able to respond to directives, requests, and queries through agreed modes of communication with their immediate supervisor and co-workers;
 - c. No record of accomplishment means no work has been performed for the day, thus, subjecting the staff to absence
- Although the latest IATF Resolution classified El Salvador City under MGCQ, this Office has observed that there has been an increase in the number of
