



Pursuant to the Civil Service Commission (CSC) Memorandum Circular (MC) No. 6 or the Guidelines in the Establishment and Implementation of an Agency Strategic Performance Management System, the Department of Education (DepEd) has adopted its internal performance management system through the issuance of DepEd Order (DO) No. 2, s. 2015 titled Guidelines on the Establishment and Implementation of the Results-based Performance Management System (RPMS) in the Department of Education. The DepEd RPMS guidelines provided for the mechanisms, protocols, and tools on the conduct of the performance target setting, monitoring, evaluation, and development planning.

In view of the developments in the education landscape, the fast changing internal and external environment, and the recent demands to effectively navigate in the new normal, it is now high time to review the service delivery and performance management in all levels of governance of the Department. With this, the Bureau of Human Resource and Organizational Development – Human Resource Development Division (BHROD-HRDD) spearheaded the revision of the RPMS Guidelines and will thus conduct validation workshops through online platform on the following dates:

a. Batch 1: June 14 to 16, 2021b. Batch 2: July 5 to 7, 2021

The workshop aims to:

- a. Integrate adopted professional standards for teachers, school heads, and supervisors to assess whether the protocols, mechanisms, and tools are still relevant and appropriate based on the current context and implementation practices of all DepEd offices, schools, and personnel in the performance management system; and
- b. Review the draft amendments in DO No. 2, s. 2015 and issue an enhanced version of the RPMS guidelines by the end of the year.

Attendance and participation of the identified representatives (*Annex A: List of Participants*) from the DepEd Central Office, regional offices (ROs), schools division offices (SDOs), and schools are requested. Attached also is the workshop's *Program of Activities* (*Annex B*) for your reference.
