

- For each standard, please create a folder for each School Year (three school years) covered. Therefore, for each standard there will be three sub-folders to be created.
- For each School Year, the necessary artifacts will be uploaded. Please label them properly for easier identification and checking. Please upload a portable data format (pdf) only.
