- 4. The DRRM Coordinators are encouraged to:
 - Intensify the Information, Education and Communication (IEC) campaign by displaying earthquake preparedness measures in offices and school bulletins or through online forums such as social media platforms and video conferences.
 - Discuss results of Family Earthquake Preparedness Homework to the PTA and barangay officials for consideration in the school and community preparedness planning, as mandated in DO No. 27, s. 2015.
 - Distribute maps containing evacuation routes and sites (at school or community) in coordination with LDRRMOs/BDRRMCS.
- 5. Due to the limitations in the conduct of mass gatherings and adherence to COVID-19 required health protocols, NSED exercises requiring physical interaction, particularly evacuation drills in Division Office and schools, are hereby suspended. However, All DepEd personnel and learners are enjoined to practice the "Duck, Cover, and Hold" procedure simultaneously at the set time.
- Proper documentation and post-activity evaluation of the said drill is required. The School and Division DRRM Coordinators shall accomplish the Google form not later than five (5) working days after the quarterly NSED.
- 7. Further, NSED report shall be filled out by DRRM Coordinators via Google form link:
