- 1. Per DepEd OULAPP Advisory No. Q-O-002, s. 2022 dated January 31, 2022, Re: SUBMISSION OF THE FY 2022 PARTNERSHIP DATA REPORTS ON THE ENHANCED DEPED PARTNERSHIPS DATABASE SYSTEM (DPDS), and pursuant to OULAPP Memo No. Q-453, s. 2021 titled "Implementation of the Enhance DepEd Partnerships Database System (DPDS)", the deadline for the submission of monthly partnership report is every 6th day of the succeeding month. The same reporting schedule shall be adopted for the Fiscal Year 2022.
- 2. The External Partnerships Service (EPS), in coordination with the Information and Communications Technology (ICTS), shall closely monitor the submission of the report and review the data uploaded in the Enhanced DPDS. The Regional and Divisional Summary captured in the Enhanced DPDS shall be reported to the DepEd Partnership Management Committee (DPMC) every month as the official partnership data. This summary will also be shared to offices needing partnership data at the DepEd Central Office.
