- 2. The online activities focus on the involvement of women, children, youth, student, and senior citizens. This drill aims to highlight the earthquake preparedness efforts in pursuit to build a more resilient community
- 3. In order to raise awareness regarding the earthquake drill, School DRRM Coordinators are encouraged to:
 - Intensify the Information, Education, and Communication (IEC) campaign by displaying information on earthquake preparedness measures at the office and school bulletins or through online forums such as social media platforms and video conferences;
 - Discuss results of Family Earthquake Preparedness Homework to the PTA and barangay officials for consideration in the school and community preparedness planning, as mandated in D.O. No. 27, s.2015; and
 - Distribute maps containing evacuation routes and sites (at school or community) in coordination with LDRRMOs/BDRRMCs.
- 4. Further, due to limitations in the conduct of mass gatherings and adherence to health protocols, NSED exercises requiring physical interaction, particularly evacuation drills in DepEd offices and schools, are hereby suspended. However, all DepEd personnel and learners are enjoined to practice the "Duck, Cover, and Hold" procedure simultaneously at the set time.
- 5. Proper documentation and post-activity evaluation are required. The School and Division DRRM Coordinators shall accomplish the Google form for the submission of the 1st Quarter NSED Report not later than five (5) working days after the quarterly NSED.
