- 1. Relative to DepEd Memorandum No. 55, s. 2021 Re: Recommended Programs, Projects and Activities of the Student Government for School Year 2021-2022, in partnership with the Local Government Unit of El Salvador City and Sinaloc Barangay Council, this Office hereby informs the field on the conduct of Mangrove Tree Planting Activity on June 3, 2022 at 6:00 AM at Sinaloc Elementary School.
- 2. This activity aims to capacitate our youth leaders the importance of restoration and reforestation. Also, it aims to stabilize the coastline, protect water quality, reduce coastal flooding, provide habitat for fish, protect wildlife species, protect young fish from predators and serve as nesting area.
- 3. Further, participants of this activity are Division Youth Formation Coordinator, District ALS Coordinator District II, SSG Teacher-Advisers and Five (5) SSG Officers. Also, each participant should bring one (1) bamboo stick (22 x 2 inches size) and a tie.
- 4. Moreover, strict adherence to the health protocol specified by the Inter-Agency Task Force (IATF) and the directive set by the Local Government unit (LGU) must be observed such as wearing of face, observing social
