The National Anti-Poverty Commission (NAPC) is organizing a two-part webinar series this 29-30 September 2022. The webinar will feature presentation-discussions from Philippine research and industry-renowned experts on the application of connecting farmers and fishers to consumers and manufacturers. It will be a platform for convening policy experts, researchers, and representatives from the government sector, the private sector, and the basic sectors/civil society to actively engage in the campaign to reduce poverty in the country.

With this theme: "Bringing the Farmers Closer to Consumers", NAPC wishes to highlight the existing socioeconomic disparities in the country which disproportionately affected the vulnerable and marginalized sectors of society, mostly the farmers and fishers. In effect, it endeavors to create equitable opportunities for the elimination of socio-economic, political, and cultural inequities. This is to make social justice a guiding principle of the country's resiliency and recovery plan, particularly in five areas: food sufficiency, human capital development, public health services, shelter, and adequate income.
