Invitation to Bid for

The *Department of Education, Division of El Salvador City*, through the *General Appropriations Act of CY 2022* intends to apply the sum of and *Eight Million Nine Hundred Thirty-Six Thousand Six Hundred Sixty-Nine Pesos & Eighty-Nine Centavos Only (Php. 8,936,669.89) for Lot 1 with Project No. 2022-10-0229 being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.*

- 2. The *Department of Education, Division of El Salvador City* now invites bids for the above Procurement Project. Completion of the Works is required *150 Calendar days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from *Department of Education*, *Division of El Salvador City* and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on *October* 26, 2022, from given address and website/s below *and upon payment of the applicable fee* for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Ten Thousand Pesos. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person*.

The Department of Education, Division of El Salvador City will hold a Pre-Bid Conference¹ on November 3, 2022, 9:00 o'clock in the morning at Department of Education, Division of El Salvador City, Conference Room, 2nd Level, Diamond Building, Zone 3, Tuburan, Poblacion, El Salvador City or via google meet subject to IATF alert level classification, which shall be open to prospective bidders.

May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a prebid conference.

- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated *Department of Education, Division of El Salvador City, Conference Room, 2nd Level, Diamond Building, Zone 3, Tuburan, Poblacion, El Salvador City on or before <i>November 15*, 2022, at 9:00 O'clock in the morning. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 9. Bid opening shall be on *November 15, 2022*, at 9:00 o'clock in the morning at the given address: *Department of Education, Division of El Salvador City, Conference Room, 2nd Level, Diamond Building, Zone 3, Tuburan, Poblacion, El Salvador City.* Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. Prospective bidders joining the opening of bids are required to observe social distancing, wearing of face mask and face shield. Interested bidders outside from the region must strictly adhere protocols set by the IATF.
- 11. The *Department of Education, Division of El Salvador City* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
