- 1. This is to inform the field that savings are already identified from our PS Fund. Accordingly, this Office will be accepting requests for Monetization of Leave Credits, with the following purpose:
 - a. Health, Medical and Hospital Needs of the employee and the immediate members of his/her family;
 - b. Financial aid and assistance brought about by force majeure events such ascalamites, typhoons, fire, earthquake and accidents that affect the life, limb property of the employee and his/her immediate family;
 - c. Education needs of the employee and the immediate members of his/her family;
 - d. Payment of mortgages and loans which were entered into for the benefit or whichincurred to the benefit of the employee and his/her immediate family;
 - e. In case of extreme financial needs of the employee or his/her immediate familywhere the present sources of income are not enough to fulfill basic needs such as food, shelter and clothing:
 - f. Other analogous cases as may be determined by the commission.

 - 2. 3 copies of duly accomplished CSC Form 6 (Revised 2020)

- If request for monetization is more than 50% or more of the leave credits:
 - a. Certification (Annex B downloaded at website)
 - Supporting documents (e.g. receipts or bill from hospital) if request is for Health, Medical and Hospitalization purposes.
- Requests must be submitted on or before 1 o'clock in the afternoon of December 21, 2022.
- Release of MLC will be on a *first-come*, *first-served* basis, except for those identified employees whose requests were returned by DBM, they will be prioritized.
- 5. This Office shall observe the Equal Opportunity Principle (EEOP). Hence, all decisions and actions relative to this matter shall be based solely on the guidelines set forth with no bias/discrimination based on race, ethnicity, sex, age, disability, national origin, religion and/or political affiliation.
