- 1. Pursuant to Article XIV, Section 19 of the 1987 Philippine Constitution, the State shall promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry.
- 2. In connection with this, the Schools are hereby encouraged to facilitate the organization of Sports Clubs to strengthen the school sports program and enhance the competitive skills of potential athletes in the division.
- 3. This aims to: a. provide a healthy sporting habit among the students and learn teamwork at work, b: infuse discipline, and instil the value system in one individual, c. develop student-athletes who excel in the various athletic events and, d. give them wide exposure of what are happening around them with respect to their clubs making them participate in local and national sports tournaments.
- 4. List of members and officers of the organized sports clubs shall be submitted to the Division Office through the Youth Formation Coordinator of the School Governance and Operations Division (SGOD).
- 5. Moreover, this activity shall adhere to the Equal Opportunity Principle (EOP) in observing all policies and protocols of the said activity. Hence, all actions
