SCHOOL – BASED INTENSIVE TRAINING FOR SINING TANGHALAN PARTICIPANTS AND COACHES FOR 2025 REGIONAL FESTIVAL OF TALENTS

To: Assistant Schools Division Superintendent Chief Education Supervisors, SGOD & CID Education Program Supervisors Elementary and Secondary School Heads All Others Concerned

- 1. In connection with the up-coming Regional Festival of Talents (RFOT), the schools are encouraged to conduct a school based intensive training for Sining Tanghalan participants and coaches for 2025 Regional Festival of Talents on March 1 10, 2025.
- 2. This activity aims to strengthen and enhance the performance of the students relative to the participation of El Salvador City Division in the up-coming 2025 Regional Festival of Talents to be hosted by the province of Lanao Del Norte.

- 6. Teaching and non-teaching participants involved in the conduct of this activity during the weekend and/or holidays shall be entitled to service credits in accordance with DepEd Order No.52, s. 2003 entitled Updated Guidelines on Grant of Vacation Service Credits to Teachers. On the other hand, non-teaching staff shall be provided with Compensatory Time Off (CTO) per Civil Service Commission and Department of Budget and Management Joint Circular No. 2, s. 2024 on Non Monetary Remuneration for Overtime Service Rendered.
- 7. Participation in this activity shall be subject to the non-disruption of classes policy stipulated in DepEd Order No.9, s.2005 titled "Instituting Measure to Increase Engaged Time on Task and Ensuring Compliance," Section 3 of Republic Act No. 5546. (Policy on Contributions) and DepEd Order No. 66, s. 2017 (Policy on Off-Campus Activities)."


