

- 4. School paper advisers shall pay an adviser's membership fee of P60.00 and student writer's membership fee of P30.00. The collection will be made by the treasurer of the organization at the divisional level and shall be remitted to the treasurer of the regional organization.
- 5. Recognizing and respecting Intellectual Property Rights, the Department adheres to the rule concerning plagiarism. DepEd reiterates its stand to disqualify school papers found to have copied and published texts, graphics, and other materials without duly acknowledging their sources. Any form of plagiarism in all competitions as proven by the board of judges shall be a ground for disqualification. The disqualification covers all sections of the school paper.
- 6. The top five winners in all contest events (except for school paper) shall be recognized.
- 7. The official delegates' travel, meals, and other incidental expenses shall be charged against the school's Maintenance and/or Other Operating Expenses (MOOE)/local/regional funds/Special Education Fund or the School Campus Journalism Fund, or other applicable sources. All expenses are subject to the usual accounting and auditing rules and regulations.
