CONDUCT OF SCREENING AND ASSESSMENT FOR IDENTIFICATION AND EDUCATIONAL PLACEMENT OF LEARNERS WITH DISABILITIES

- 1. Pursuant to DepEd Order No. 42, s. 2021, titled "National Policy and Framework on Learners and Education Personnel with Disabilities," as amended by DepEd Order No. 18, s. 2022, this Office announces the Conduct of Screening and Assessment for Identification and Educational Placement of Learners with Disabilities by Lead Psychological Services Team from Cagayan De Oro City on August 1–2, 2025, at El Salvador City Central School, Poblacion, El Salvador City.
- 2. The activity aims to:
 - a. identify learners with disabilities in need of educational placement,
 - b. provide appropriate recommendations based on individual learning needs, and
 - c. strengthen inclusive education services across the division.
- 3. Participants to this activity are the school SNED teachers in this Division, Learners with Disabilities (LWDs), school heads, medical team, and parents of the LWDs.
- 4. The school heads with SNED classes are requested to coordinate with parents/guardians of concerned learners and ensure their attendance during the scheduled assessment. Transportation and food expenses of participating personnel shall be charged against local funds or other available sources subject to usual accounting and auditing rules and regulations.
- 5. The list of LWDs to be assessed was already sent to the school SNED Focal person.
- 6. Moreover, this office adheres to the Equal Opportunity Principle (EOP) in observing all policies and protocol of the said activity. Hence, all actions shall be based solely on guidelines set with no discrimination on the account of age, gender, identity, sexual orientation, civil status, disability, religion, ethnicity, or political affiliation.
