

Pursuant to DepEd Order No. 42, s. 2021, titled "National Policy and Framework on Learners and Education Personnel with Disabilities," as amended by DepEd Order No. 18, s. 2022, this Office announces the Conduct of Screening and Assessment for Identification and Educational Placement of Learners with Disabilities on August 1-2, 2025, at El Salvador City Central School, Poblacion, El Salvador City.

2. The activity aims to:

- a. identify learners with disabilities in need of educational placement,
 b. provide appropriate recommendations based on individual learning needs,
- c. strengthen inclusive education services across the division.
- 3. Division participants in this activity are the school SNED teachers, school heads with SNED classes, and the medical team.
- 4. Further, the participants are entitled to vacation service credits in accordance with DepEd Order No. 013, s. 2024 "Revised Guidelines on the Grant of Vacation Service Credits for Teachers" or DepEd Order No. 009, s. 2025 "Amendment to DepEd Order No. 009, s. 2024 (Implementing Guidelines on the School Calendar and Activities for the School Year 2024-2025)," or compensatory time-off pursuant to CSC-DBM Joint Circular No. 2, s. 2004 "Non-Monetary Remuneration for Overtime Services Rendered," whichever is applicable.
