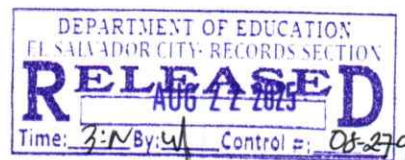

1. The Curriculum Implementation Division (CID) of this Office will conduct a Quarterly Program Implementation Review (PIR) for Kindergarten and Special Needs Education (SNED) teachers. The review is scheduled for the following dates: August 29, 2025; October 24, 2025; January 30, 2026; and March 27, 2026. All sessions will take place at the El Salvador City Central School ICT Room from 8:00 AM to 5:00 PM.
2. The PIR aims to
 - a. review the implementation of kindergarten learning delivery and curriculum,
 - b. identify issues and gaps in teaching and learning,
 - c. share innovative practices and interventions that support early literacy, and numeracy, and
 - d. recommends actions to enhance the delivery of quality kindergarten education.
3. All Kindergarten and SNED teachers are instructed to prepare and present a 5-minute PowerPoint report that highlights their accomplishments, challenges encountered, and proposed interventions for the quarter. School heads shall provide technical assistance and ensure full support for their participation.
5. Expenses relative to the conduct of this activity shall be charged to local funds, school MOOE, or other available sources, subject to existing accounting and auditing rules and regulations.
6. This Memorandum served as the travel order of the participants.
7. Moreover, this Office adheres to the Equal Opportunity Principle (EOP) in observing all policies and protocols of the said activity. Hence, all actions shall be based solely on guidelines set with no discrimination on account of age, gender,
