CONTRACT AGREEMENT

Contract No. 2025-08-0004

THIS AGREEMENT made on the 14th day of August 2025 between **Department of Education, Division of El Salvador City**, located at Zone 3, Tuburan, Poblacion, El Salvador City of the Philippines, represented herein by its Schools Division Superintendent, **RANDOLPH B. TORTOLA**, (hereinafter called “the Entity”) of the one part and **THE LIFE GIVING PRODUCTS AND SPECIALTY (MANHU - THE LIFE GIVING BREAD) CORPORATION**, represented herein by **GILBERT A. GABUTAN**, with office address at *TLGPSC Bldg., Sitio Moloypoloy South Diversion Road, Manhu Drive, Indahag, Cagayan de Oro City* by (hereinafter called “the Supplier”) of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Procurement of Supply and Delivery of Fortified Bread for SBFP SY 2025-2026 (Lot 4)** and has accepted the Bid for **ONE HUNDRED SIXTY-SIX THOUSAND TWO HUNDRED FIFTY-ONE PESOS ONLY (Php. 166,251.00)** (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:

- a) Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
- b) Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;

- c) Performance Security;
- d) Notice of Award of Contract; and the Bidder’s conforme thereto;

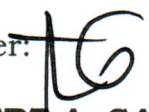
- e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **ONE HUNDRED SIXTY-SIX THOUSAND TWO HUNDRED FIFTY-ONE PESOS ONLY (Php. 166,251.00)** or such other sums as may be ascertained, the Contractor agrees to complete the ***Procurement of Supply and Delivery of Fortified Bread for SBFP SY 2025-2026 (Lot 4)*** in accordance with his Bid.
4. The ***Department of Education, Division of El Salvador City*** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.

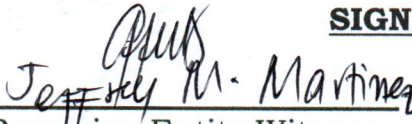

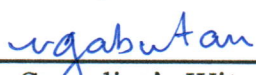

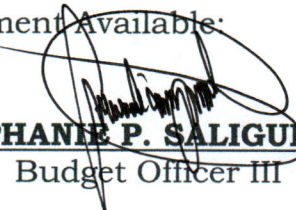
