CONTRACT AGREEMENT
Contract No. 2025-08-0008

THIS AGREEMENT made on the ____ day of 05 SEP 2025 2025 between **Department of Education, Division of El Salvador City**, located at Zone 3, Tuburan, Poblacion, El Salvador City of the Philippines, represented herein by its Schools Division Superintendent, **RANDOLPH B. TORTOLA**, (hereinafter called “the Entity”) of the one part and **PHILIPPINE FAMILY FARMERS AGRICULTURE FISHERMAN FORESTRY COOPERATIVE FEDERATION (AGRICOOOPH)**, represented herein by **JOEL R. FANUGA**, with office address at *1 Ladislao Diwa, Concepcion Uni, Marikina City* by (hereinafter called “the Supplier”) of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Procurement of Supply and Delivery of Enhanced Cookies and Juice for SBFP SY 2025-2026 (REBID), with PN No. 2025-08-0012 (Lot 5)** and has accepted the Bid for **THREE HUNDRED NINETY-SEVEN THOUSAND SEVEN HUNDRED THIRTY-FOUR PESOS ONLY (Php. 397,734.00)** (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - a) Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - b) Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;

- d) Notice of Award of Contract; and the Bidder's conforme thereto; and
- e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **THREE HUNDRED NINETY-SEVEN THOUSAND SEVEN HUNDRED THIRTY-FOUR PESOS ONLY (Php. 397,734.00)** or such other sums as may be ascertained, the Contractor agrees to complete the **Procurement of Supply and Delivery of Enhanced Cookies and Juice for SBFP SY 2025-2026 (REBID), with PN No. 2025-08-0012 (Lot 5)** in accordance with his Bid.
4. The **Department of Education, Division of El Salvador City** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
