AMENDED BY-LAWS OF THE PHILIPPINE PUBLIC SCHOOL TEACHERS ASSOCIATION, INC.

ARTICLE I - NAME

Section 1 - The name of the organization shall be PHILIPPINE PUBLIC SCHOOL TEACHERS ASSOCIATION, INC., hereinafter referred to as the "PPSTA".

ARTICLE II - OBJECTIVES

Section 1 - The objective of the PPSTA shall be to promote the interest and welfare of the Philippine public school systems and of public education personnel. Specifically, the PPSTA shall seek:

- a) To provide the course of education as an agency for Filipino nationalism and promote the principles of the ASEAN Council of Teachers + 1 (ACT+1) and Education International (as amondra on october 16, 2020)
- b) To protect and help its members.
- c) To keep its members in close touch with one another.
- d) To operate and maintain a mutual aid and benefit systems and related financial institutions which shall provide financial assistance to members and their designated beneficiaries or dependents. (as amended on October ly, 2020

ARTICLE III - MEMBERSHIP

Section 1 - The following may become members of the PPSTA:

- a) All teaching and non-teaching personnel of public schools in the Philippines;
- b) Personnel of the PPSTA and its local chapters;
- c) Retirees, resignees or transferees previously belonging to a) or b) above; and
- d) Independent trustees during the duration of their term of office. (as amended on October 14, 2020)

Section 2 - There shall be three (3) classes of members, namely:

- a) Regular members all members who belong to any of those listed in Section 1 and who have applied and been accepted as members of the PPSTA;
- b) Life Members regular members who paid the duly approved life membership fee; and
- c) Honorary Members persons who do not belong to those listed in Section 1 but have played important roles in the promotion and preservation of the welfare of the PPSTA and whose
