CONTRACT AGREEMENT
Contract No. 2025-12-0013

THIS AGREEMENT made on the DEC 11 2025 day of **December 2025** between **Department of Education, Division of El Salvador City**, located at Zone 3, Tuburan, Poblacion, El Salvador City of the Philippines, represented herein by its Schools Division Superintendent, **RANDOLPH B. TORTOLA**, (hereinafter called "the Entity") of the one part and **ABRAHAM BM CONSTRUCTION**, represented herein by its owner **AMMAR M. MARADANG**, with office address at *Amar Residence, Mustafa Compound, Purok Manuang, Tubod, Iligan City* by (hereinafter called "the Contractor") of the other part;

WHEREAS, the Entity is desirous that the Contractor execute **Procurement of Repair and Rehabilitation of Classrooms at Hinigdaan NHS with PN No. 2025-11-0016** (herein called "the Works") and the Entity has accepted the Bid for **FIVE MILLION FORTY-FIVE THOUSAND THREE HUNDRED SIXTY-EIGHT AND 6/100 PESOS ONLY (Php. 5,045,368.06)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.:*
 - a) Philippine Bidding Documents (PBDs);
 - i. Drawing / Plans;
 - ii. Specifications;
 - iii. Bill of Quantities
 - iv. Detailed Unit Price Analysis (DUPA);
 - v. General and Special Conditions of Contract; and
 - vi. Supplemental or Bid Bulletins, if any
 - b) Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - c) Performance Security;
 - d) Notice of Award of Contract; and the Bidder's conforme thereto; and
 - e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that**

In consideration for the sum of the Bid for **FIVE MILLION FORTY-FIVE THOUSAND THREE HUNDRED SIXTY-EIGHT AND 6/100 PESOS ONLY (Php. 5,045,368.06)** or such other sums as may be ascertained, the Contractor agrees to complete the **Procurement of Repair and Rehabilitation of Classrooms at Hinigdaan NHS with PN No. 2025-11-0016** in accordance with his Bid within **120** Calendar Days.
4. The **Department of Education, Division of El Salvador City** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
