GUIDELINES ON THE YEARLY COLLECTION OF DATA/INFORMATION REQUIREMENTS AND VALIDATION PROCESSES

To: Undersecretaries Assistant Secretaries Bureau and Service Directors Regional Directors Schools Division Superintendents Public and Private Elementary and Secondary School Heads All Others Concerned

- The Department of Education issues the enclosed guidelines on the Yearly Collection of Data/Information Requirements and Validation Processes, together with the Data Gathering Forms and Matrix of Accountability, Escalation Process, and Data Dictionary to provide guidance to all schools in the data collection of basic education statistics.
- All public and private elementary, junior and senior high schools, state universities and colleges (SUCs), local universities and colleges (LUCs) and higher education institutions (HEIs) offering Kindergarten to Grade 12 are directed to register and update their learners' profile and quick count enrollment in the Learner Information System (LIS) and update the school's profile and other data elements in the Easic Education Information System (BEIS) through the accomplished data gathering forms.
- 3. The LIS and BEIS can be accessed on the website http://lis.deped.gov.ph. A single sign-on is available, linking in the system.
- 4. All previous issuances relative to this Order, which are found inconsistent are deemed superseded or modified accordingly.
- 5. Immediate dissemination of and strict compliance with this Order is directed.
