**RESOLUTION TO AWARD**

**WHEREAS**, the Department of Education, Division of El Salvador City advertised the Invitation to Apply for Eligibility and to Bid for the **Procurement of Repair and Rehabilitation of Classrooms at Hinigdaan NHS with PN No. 2025-11-0016** and posted the same in the PhilGEPS;

**WHEREAS**, in response to the said advertisement/s, two (2) bidders submitted bids during the opening;

**WHEREAS**, during the opening of bids on *November 26, 2025*, one (1) bidder passed in the preliminary evaluation of bids with **TRI FB CONSTRUCTION AND GENERAL MERCHANDISE** as the lowest calculated bid as read below;

**WHEREAS**, during the bid evaluation result deliberation conducted by the Technical Working Group (TWG) on *November 26, 2025* for **TRI FB CONSTRUCTION AND GENERAL MERCHANDISE**, the Bids and Awards Committee (BAC) declared the bidder disqualified due to the following reason(s):

1. Referring to the Financial Document under Program of Works - Detailed Cost Estimate, item 6c, the required quantity for Hollow Core Flush Door by the agency is 14.76 sq.m. while the prospective bidder indicated 5.89 sq.m. Therefore, the prospective bidder does not meet the minimum requirements of the agency.

**WHEREAS**, the BAC proceeded to conduct a post qualification evaluation of the next Lowest Calculated and Responsive Bid, **ABRAHAMBM CONSTRUCTION** on *December 2, 2025*, declared as *passed*, and therefore, considered for award of the contract;

**NOW, THEREFORE**, We, the members of the BAC, hereby RESOLVE as it is RESOLVED to recommend the award of contract to **ABRAHAMBM CONSTRUCTION** for the **Procurement of Repair and Rehabilitation of Classrooms at Hinigdaan NHS with PN No. 2025-11-0016** in the sum of **FIVE MILLION FORTY-FIVE THOUSAND THREE HUNDRED SIXTY-EIGHT AND 6/100 PESOS ONLY (Php. 5,045,368.06)**.
