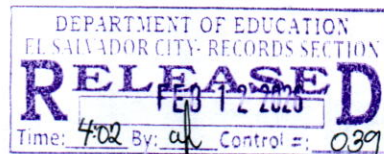

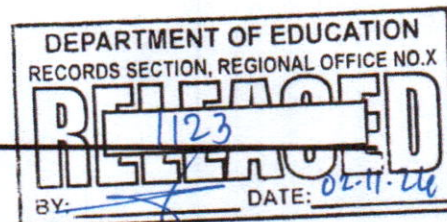

SCREENING AND ACCREDITATION OF DELEGATION DOCUMENTS
FOR THE 2026 PALARONG PAMPOOK

To: Schools Division Superintendents
All others concerned

1. Following **Regional Memorandum No. 046, s. 2026**, titled **2026 Northern Mindanao Regional Athletic Association (NMRAA) Meet (Palarong Pampook)**, to be hosted by the Provincial Government of Bukidnon and cohosted by the Divisions of Malaybalay City and Valencia City on March 18-24, the Regional Screening and Accreditation Committee (RSAC) will conduct the screening and evaluation of documents submitted by the participating Schools Division Offices (SDOs).
2. The screening is intended to ensure that all participating delegations comply with the prescribed eligibility, accreditation, and documentary requirements in accordance with Rule V, Section 19, 20, and 21 of the Implementing Rules and Regulations (IRR) of R.A. No. 10588 otherwise known as the *Palarong Pambansa Act of 2013*, as well as the guidelines on the eligibility of athletes and the corresponding amendments issued by the National, Regional, and Division Screening and Accreditation Committees of the Palarong Pambansa.
3. All concerned SDOs shall submit complete, accurate, and duly signed documents within the prescribed timeline as provided. Incomplete and non-compliant submissions shall not be processed and may result in delayed accreditation or disqualification.
4. The RSAC shall thoroughly review, validate, and endorse only those documents found to be in order, and shall submit the final list of duly accredited participants for the **2026 PALARONG PAMPOOK** to the appropriate office for approval and notation. In the absence of the DSAC Chair, a duly designated representative shall perform the required functions.
5. Attached are the schedules for the screening and accreditation of delegates for the guidance and compliance of all parties concerned.
6. Travel expenses for the RSAC and DSAC Members shall be charged to local funds, subject to the usual accounting and auditing rules and regulations. February 17, 2026, is declared a Special Non-Working Holiday pursuant to Proclamation No. 1006 issued by the President of the Philippines in celebration of the Chinese New Year, as well as any Special Non-Working Holidays that may be declared subsequently. Consequently, travel undertaken to and from the official work assignment on said dates shall be credited as Compensatory Time Off (CTO).

7. Strict compliance with this directive is enjoined to ensure the orderly, transparent, and efficient conduct of the 2026 PALARONG PAMPOOK.

8. This Office hereby directs the immediate and wide dissemination of this Memorandum.
