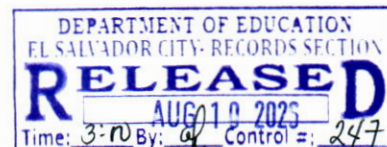

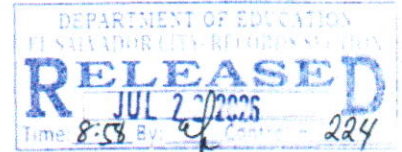

1. Committed to strengthening curriculum implementation, ensuring the development of quality-assured learning resources, and promoting innovative instructional delivery, this Office announces the implementation of the project titled **Resources for Learning Futures 2.0 (RLF 2.0)**.

2. This initiative aims to establish a systematic, standards-based, and collaborative process for the development, evaluation, quality assurance, uploading, and dissemination of Lesson Plans and Learning Resources (LRs) aligned with the curriculum standards, inclusive education principles, and future-ready teaching practices.

3. Timeline for Term 2:

- a. General Orientation- July 21
- b. Development – July – August
- c. Evaluation Phase (Content, Social Content, Language, and Layout) – August 3-7
- d. Finalization and Uploading – August 17-20

4. The development and evaluation activities shall be conducted outside regular instructional time, such as during non-class hours, weekends, holidays, vacation periods, or other duly approved schedules, to ensure that classroom instruction and learner contact time are not disrupted. Teachers engaged as learning resource developers may be granted service credits or compensatory time off (CTO) of up to four days, while teachers engaged as evaluators may be granted up to two days, based on the actual number of days rendered and the satisfactory completion of assigned tasks and expected outputs. The granting of service credits or CTO shall be subject to the submission of duly certified accomplishments, certification by the immediate supervisor, and compliance with the provisions of DepEd Order No. 52, s. 2023, and CSC-DBM Joint Circular No. 2, s. 2016.

5. The prescribed lesson plan templates may be accessed through this link <https://bit.ly/dlptemplateRX>. All developers shall use the official templates to ensure consistency in format, content organization, and quality assurance.

6. Submit completed Learning Resources to the Learning Resource Supervisor.

IV. EVALUATION PHASE

Learning Resource Supervisor

Responsibilities:

1. Maintain and regularly update the tracking system;
2. Distribute developed Learning Resources to Content Evaluators;
3. Facilitate coordination between Developers and Evaluators for revisions;
4. Ensure iterative review until Learning Resources meet content standards;
5. Endorse approved Learning Resources to Language Evaluators;
6. Facilitate final sign-off by the Learning Resource Supervisor and Learning Area Supervisor; and
7. Ensure compliance with quality assurance standards.

V. UPLOADING PHASE

Lead Office:

Learning Resource Supervisor

Required Files:

File 1 – Final Signed Version

Includes complete evaluation signatures and approval pages.

File 2 – Teacher Version

Version without summative assessments and signatures.

File 3 – Consolidated Assessment File

Contains complete summative assessments for the term.

Pre-Upload Quality Check:

1. Completeness of all required files;
2. Correct versioning;
3. Compliance with formatting standards;
4. Accuracy of file naming conventions; and
5. Verification of content quality and accessibility.
